II. PIO Presentation led by Alayna Evans and Mikaylee Garcia

A. PIO is coming to give a new proposal after being in discussion with President Compaan and Vice President McIntyre regarding SGA's previous concerns.

Originally, PIO was requesting 10,000 dollars in support from SGA for the Lu'au taking place on April 6th but has now changed the amount they are asking for to 5,000 dollars. This decision was made after examining the club's financial standing, a desire for future sustainability, and separation from the Homecoming Committee. Now everything will be done by PIO and all costs and profits will go directly to the organization. This will allow them to be more independent and return to a fully student-run event. The biggest expense is catering which will cost 7,000 dollars. SGA's contribution will help make a dent in this cost. With a lower monetary contribution, PIO desires to create more collaboration with SGA in the hosting of the event. This could look like SGA helping with advertising or

video. For the day of the event, this support could be helping with clean up, ticketing and ushering, serving and plating food, and participating in the event as dancers. They want to make this a collaborative effort between the two organizations and promote our presence on campus.
